



Privacy Policy for Shareholder

Sun Vending Technology Public Company Limited (the “Company”) realizes the importance of personal data of shareholders and the proxies; it therefore announced this Privacy Policy for the collecting, using, processing, retention and rights of data owners, as follows:

What personal data can be collected by us?

For the purposes of this Privacy Policy, “Personal Data” means any information about an individual from which that individual can be identified, either directly or indirectly, as defined below.

Personal data of shareholders that the Company directly received from Thailand Securities Depository Co., Ltd. (TSD), received from proxies or from video recording of the shareholders meeting. For example, name-surname, ID number, passport number, gender, age, occupation, address, e-mail address, phone number, bank account, details of shareholding/securities, including information from taking photo or recording voice or video. As for the Health information and health-related travelling information, this will be collected by the Company only as necessary for screening and controlling infectious diseases or epidemics.

the Company will collect, use, and/or disclose sensitive personal data only with express consent or as permitted by law.

For what purposes does the Company collect, use and/or disclose personal information?

The Company collects, uses, processes and discloses your personal data for performing its legal obligations in relation to the holding of shareholders meeting, the communication and other services for shareholders such as delivery of documents by post mail or e-mail, communication, identification for attending the meeting, record the meeting minutes completely, collect information to prevent and suppress dangers to life or health, in case of emergency to prevent infectious diseases, including to perform other duties as prescribed by law.

To whom do we disclose your personal data?

The Company may disclose your personal data to the service providers of the shareholder meeting system, internet provider, software provider, website developer, regulatory and judicial authority required by law or legal consultant, financial advisors, lawyer, external accountant, relevant to legal compliance, and may be disclosed to public through the Company’s website. In such case, the Company will take necessary measures to ensure appropriate safeguards of your personal data pursuant to the law of Thailand in force at that time.



How long will the Company keep personal data?

The Company keeps your personal data only for as long as required to do so by the terms stated here, i.e., personal data relating to arrangement and attending the shareholders meeting will be retained for 1 month after the shareholder meeting date. After the required period, the Company will erase or destroy your personal data at the end of retention period with safe procedure in accordance with the legal requirement. For other personal data, such as the data included as a part of the minutes of the meeting will be retained or public according to document retention policy of the Company and/or legal compliance.

Policy reviews and improvement

The Company will review the Policy to be in accordance with our practices and applicable laws. In case of any change to the Policy, the Company will post the change on the website.

Rights of personal data owners

Before the end of our retention period and legal obligation of the Company, you have the right to access, correct, delete, or restrict the data processing or transfer your personal data. In such case, kindly contact the Company at the contact details below.

Reservations of the Company

The Company reserves the rights to consider your request and may refuse your request in order to comply with the relevant law, such as, in the case that the requester cannot prove that he/she is the owner of such data, or the request is not reasonable or repetitive, or the implementation upon your request would have negative impact on others, or the Company has to process such data according to legal obligation, or the Company has already deleted such data as the retention period has lapsed.
